Public Comment:

There are in-person and remote options for members of the public who would like to participate in Council meetings.

1. In-Person:

General Public Comment:

- Members of the public can speak to any item that is NOT an ordinance on the regular agenda.
 Members may also request that any item on the Consent Agenda labeled as quasi-judicial, be placed on the Regular Agenda for discussion and public comment or testimony.
- Individuals who wish to speak are asked to <u>fill out a card provided</u> in Chambers and give this to
 the City Clerk. The Mayor will call people up to comment in the order the cards were received.
 Cards are only required for the general public comment portion of the meeting. Each person
 will have three minutes to speak. Public comment is limited to residents of Larimer County, and
 individuals who own property or have business interests in the City.
- Individuals who wish to speak in-person but did not fill out a card <u>may</u> have a chance to comment once all in-person and online speakers who have registered are called on, if there is any time remaining. General Public Comment is limited to 60-minutes.

Regular Agenda Items:

- No cards are required for individuals wanting to provide public comment on items included on the Regular Agenda.
- If an individual comments on a Resolution item shown on the Regular Agenda during General Public Comment, no additional comment can be given once the item comes up for discussion on the Regular Agenda.
- Once a motion is made on an item shown on the Regular Agenda, the Mayor will ask for public comment. The Mayor will invite speakers to comment at that time. In-person comment will occur first, followed by online public comment.

2. Remote:

- Members of the public who wish to provide public comment remotely, can log in using the
 meeting ID provided above, or opening your <u>meeting app or accessing the web browser</u>
 and entering the Meeting ID shown above after 5:45 pm, at which time you will be muted and
 added to the meeting.
- Members of the public can also call 1 (719) 359-4580 and enter the meeting ID when prompted: 97537796504# followed by the meeting passcode: 829866#. If you would like to speak during public comment, please press *9. The moderator will call on the users' last 4 digits of the phone number, and you will press *6 when called on by the moderator.

General Public Comment:

- Members of the public can speak to any item that is NOT an ordinance on the regular agenda. Members may also request that any item on the Consent Agenda labeled as quasi-judicial, be placed on the Regular Agenda for discussion and public comment or testimony.
- Remote Individuals who wish to speak are asked to <u>register online at lovgov.org/CouncilPublicComment</u> by 12:00 noon on the day of the meeting. The Mayor will call on people to comment in the order the registrations were received. This will follow inperson comment. Online registration is only required for the General Public Comment portion of the meeting.
- To speak to an agenda item when public comment is called for, please choose the raise your hand feature on the application. The moderator will then individually unmute the speaker and

the speaker will need to follow the moderator's instructions before making comment. This will include turning on video. Each person will have three minutes to speak. The line will be muted at the end of the three minutes. Public comment is limited to residents of Larimer County, and individuals who own property or have business interests in the City.

• Individuals who wish to speak remotely but did not register <u>may</u> have a chance to comment once all in-person and online speakers who have registered are called on, if there is any time remaining. General Public Comment is limited to 60-minutes.

- If an individual comments on a Resolution item shown on the Regular Agenda during General Public Comment, no additional comment can be given once the item comes up for discussion on the Regular Agenda.

DISCUSSION REGARDING REVISED CITY OIL AND GAS REGULATIONS

Information Only

The purpose of this Study Session is to gain feedback from City Council on the proposed changes to the current regulations that would put additional restrictions on the oil and gas

applicants and operators in the future. Staff will also present a path forward for public outreach and seeks City Council input on the approach. As the City Council may recall, a sixmonth moratorium on new oil and gas operation applications was approved on November 28, 2023 and Staff is requesting said moratorium be extended to September 1, 2024. An extension of 90 days from June 1, 2024 to September 1, 2024 should provide the additional time needed for a robust public outreach process, preparation of the new regulations, and public hearings before both Planning Commission and City Council.
