Public Comment:

Cards are only required for the general public comment portion of the meeting. Each person will have three minutes to speak. Public comment is limited to residents of Larimer County, and individuals who own property or have business interests in the City.
- Individuals who wish to speak in-person but did not fill out a card may have a chance to comment once all in-person and online speakers who have registered are called on, if there is any time remaining. General Public Comment is limited to 60-minutes.

Regular Agenda Items:

The purpose of this proposed Ordinance is for the City Council to approve the voluntary property owner nomination application for a local landmark at 1131 N. Garfield Ave. as presented, finding that it meets the following Historic Preservation Ordinance 5160 criteria. If approved, the local landmark is listed on the Loveland Historic Register and is protected from demolition or exterior alterations that negatively affect the historic character of the property in the future. Historic landmarks are eligible for financial benefits such as state tax credits and construction fee waivers, the zero-interest loan program offered by the Loveland Historic Preservation Program, and state and federal grants. There are no General Fund (GF) unassigned fund balance impacts associated with this proposal.

ORDINANCE AMENDING SECTION 18.02.02.03 OF THE LOVELAND MUNICIPAL CODE, THE SAME RELATING TO ZONING REGULATIONS FOR CERTAIN PROPERTY LOCATED IN TRACTS A AND B, GROSBOLL ADDITION TO THE CITY OF LOVELAND, LARIMER COUNTY, COLORADO AND APPROVING THE ASSOCIATED ZONING DOCUMENT FOR KENTRO GROUP CLUSTERED

HOUSING DEVELOPMENT

A motion to adopt, on second reading, Ordinance No. 6703 amending Section 18.02.02.03 of the Loveland Municipal Code, the same relating to zoning regulations for certain properties located in Tracts A and B, Grosboll Addition to the City of Loveland, Larimer County, Colorado and approving the associated zoning document for Kentro Group Clustered Housing Development

The purpose of this City Council action is associated with 25.85 acres of property in the South Central area of Loveland, on the south side of 14th Street SW and west of the Burlington Northern Santa Fe railroad. The land is currently vacant, covered in grass, and has a varied topography. The request is to amend the Comprehensive Plan, rezone, and approve a Zoning Document for the subject property. It is currently designated CC Corridor Commercial in the Comprehensive Plan, and the proposed designation is MDR Medium Density Residential. It is currently zoned DR-Developing Resource, and the proposed zoning is Planned Unit Development (PUD). Approval of this Amendment, Planned Unit Development zoning, and Zoning Document would allow for the submittal to the City of additional development applications, including a subdivision plat, site development plan, civil construction plans, site work permit, and building permits. These will be reviewed administratively, and must comply with all Standards and other applicable Municipal Code requirements. If these are then approved, a new clustered housing development can move forward on this property.

The Planning Commission reviewed this application on March 24, 2024 and voted 8-0 to recommend City Council approval, with the following condition to the Zoning Document:

1) The total number of housing units developed on the property, regardless of unit type or size, shall include between 143 and 193 total housing units, which is within 15% of the number of housing units shown on the illustrative site plan included with the March 25, 2024 Planning Commission public hearing agenda packet.

At the first City Council hearing on April 16, 2024, the Council adopted Resolution #R-49-2024 approving the amendment to the City of Loveland Comprehensive Master Plan, designating the subject property as Medium Density Residential. While the summary of the Kentro proposal in this AIR includes references to the Comprehensive Plan Amendment, it should be noted that resolutions do not undergo second readings by Council. Thus, the second reading of the associated Zoning Document ordinance is the topic of the May 7, 2024 Council meeting.

RESOLUTION ADOPTING NEW ELECTRIC RATES FOR ELECTRIC VEHICLE CHARGING STATIONS FOR COMMERCIAL CUSTOMERS WITHIN THE SCHEDULE OF RATES, CHARGES, AND FEES FOR SERVICES BY THE WATER AND POWER DEPARTMENT OF THE CITY OF LOVELAND

A motion to adopt, on second reading, Resolution #R-50-2024 adopting new electric rates for electric vehicle charging stations for commercial customers within the schedule of rates, charges, and fees for services provided by the Water and Power Department of the City of Loveland

The purpose of this proposed Resolution is to directly address several inquiries from local Commercial Power customers asking whether the City of Loveland Power Utility offers Electric Vehicle (EV) Charging Station rates, and why rates are currently not available. When considering whether to add a new customer class for any of the Utilities, a question that must be addressed is whether there is a need for a new customer class. In general, customer classes are developed so that a given set of customers that has similar usage characteristics can be grouped together and billed for their usage in a consistent way. Since EV Charging Stations have very different usage characteristics than a Commercial business that operates out of a building, it makes sense to create a rate specifically for EV Charging Stations that are installed at a business. This new rate class will better support local Commercial customers and their interests in installing EV charging stations for the benefit of their employees or

customers. This effort is being done solely within the Power Utility.

Currently there is no Local Licensing Authority available should the Municipal Judge be unable to preside over hearings or due to recusal. In the event that a conflict of interest is presented with a licensee also involved in criminal proceedings in municipal court, the municipal judge must recuse from all licensing matters. Liquor and Tobacco Licensing impact the City of Loveland in two areas: public safety and economic development. Without significant regulation, negative impacts to the community may increase or compound, creating a risk to life and property. Lack of enforcement presents a precedent for bad actors. This places additional strain on law enforcement when administrative penalties cannot be enforced in a timely manner, and weakens the enforcement capacity of City departments.
