placed on the Regular Agenda for discussion and public comment or testimony.

- Individuals who wish to speak are asked to <u>fill out a card provided</u> in Chambers and give this to
 the City Clerk. The Mayor will call people up to comment in the order the cards were received.
 Cards are only required for the general public comment portion of the meeting. Each person
 will have three minutes to speak. Public comment is limited to residents of Larimer County, and
 individuals who own property or have business interests in the City.
- Individuals who wish to speak in-person but did not fill out a card <u>may</u> have a chance to comment once all in-person and online speakers who have registered are called on, if there is any time remaining. General Public Comment is limited to 60-minutes.

Regular Agenda Items:

- No cards are required for individuals wanting to provide public comment on items included on the Regular Agenda.
- If an individual comments on a Resolution item shown on the Regular Agenda during General Public Comment, no additional comment can be given once the item comes up for discussion on the Regular Agenda.
- Once a motion is made on an item shown on the Regular Agenda, the Mayor will ask for public comment. The Mayor will invite speakers to comment at that time. In-person comment will occur first, followed by online public comment.

The purpose of this proposed Ordinance is to adopt the updated Loveland Emergency Operations Plan (LEOP), which is required under the Colorado Disaster Emergency Act and the federal Stafford Act. Our Municipal Code (Chapter 2.72.010) has established that we would follow this plan and update it regularly. This document provides an overview of the jurisdiction's emergency response and policies, and cites legal authority for emergency operations. Failure to move forward with this ordinance would mean the City will be working off an outdated (2012) emergency plan and may not have adequate responses models and resources available during an emergency. Failure to update would also cause the LEOP to not follow the updated (2021) FEMA guidelines.

The purpose of this proposed Ordinance is to vacate an approximate 6-foot wide by 220-foot long portion of the south side of the Kendall Parkway right-of-way, located between Mirror Lake Drive and John Glenn Drive. This already-constructed east-west stretch of Kendall Parkway is generally situated north of Houts Reservoir, south of the Centerra Industrial development, east of N. Boyd Lake Avenue and west of Rocky Mountain Avenue. The total area to be vacated is 1,317 square feet. As is conventional with right-of-way vacations, the vacated sliver of land will become a part of the adjacent property (Outlot F, Millennium Northwest Twenty-First Subdivision).

The purpose of this proposed Resolution is to award a services contract amendment to Muller Engineering, Inc. in the amount of \$1,194,105.00 for Phase 2, Field Inspection Review (FIR) and preliminary design, of the Highway 287 Flood Mitigation Project. Conceptual design of this capital project began in September 2023 and is being funded by a Hazard Mitigation Grant Program (HMGP) grant from the Federal Emergency Management Agency (FEMA) to the State of Colorado's Division of Homeland Security & Emergency Management. Muller Engineering was selected on July 7, 2023, through a competitive Request for Proposals process meeting both City and Federal procurement requirements. Additional contract amendments will occur in the future for final design scope of services as those services are further defined. The City's 10 percent local match to the HMGP grant will be funded through the City's Stormwater Enterprise River Fund.

City Council approval is necessary to execute the IGAs and to authorize the use of the North Front Range Metropolitan Planning Organization (NFRMPO) grant funds that was awarded for three projects in 2023. The project grant funds will become available in CDOT Fiscal Years 2026 and 2027, and construction is anticipated in those years. Local matching funds must be used and will be included in future budgeting for capital projects City match funding will include both General Fund (GF) and Street Capital Expansion Fees (CEF).

PROCEDURAL INFORMATION

Council will give anyone in the audience time to speak to any item on the Regular Agenda before acting upon it. The Mayor will call for public comment as part of the consideration of each item according to State law, the Charter, its Rules of Procedure and other legal requirements. Loveland's Charter only requires that a majority of the quorum present vote in favor to adopt an ordinance on first reading. However, adopting an ordinance on second or final reading requires that at least five of the nine Council members vote in favor.

A motion to adopt, on second reading, Ordinance No. 6709 of the City of Loveland, Colorado, amending portions of Title 18 of the Loveland Municipal Code also known as the Unified Development Code to establish the land use category of a homeless shelter

The proposed Ordinance and the associated update of the Unified Development Code (UDC) focuses on land use and zoning for homeless shelter activities. Homeless shelter is not currently a defined land use in the UDC, and it is not listed as being allowed in any zone district. The Code amendment addresses this by defining a homeless shelter, identifying potential zone districts for a shelter to locate in, and establishing special use standards for the operation of a shelter. Staff is proposing that a homeless shelter be allowed in the B – Business zone district and the I – Industrial zone district as a conditional use. The conditional use process requires neighborhood outreach and Planning Commission approval. The Planning Commission's decision can be appealed to City Council.

This item was heard for first reading at the June 4, 2024 City Council Regular Meeting where it passed with a vote of 7-1. Based on City Council direction, a new standard has been included that requires coordination of the safety and security plan with the school district for any shelter proposed within 500 feet from a school site.

townhomes, and multiplex housing types would be allowed on the subject property. The maximum density proposed aligns with the MDR-Medium Density Residential designation in the Comprehensive Plan, allowing up to 10 dwelling units per acre or approximately six residential units in 0.56 acres in size.

Electric and Communications Enterprise revenue will increase with the bond proceeds and expenses will increase a corresponding amount so that all tax-exempt bond proceeds are invested as indicated within three years of receipt per tax-exempt bond financing requirements. This estimate includes adjustments for other municipalities that will share in election costs and some additional charges that will be applied to the City of Loveland for TABOR.
